# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to https://eliteteamlogistics.com/, and Elite Team Logistics and governs data collection and usage. # **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. - Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
